Town of West Seneca Garbage and Recycling Tote Guidelines



BLUE LID = Garbage GREEN LID = Recycling



Distribution of totes is now **COMPLETE!** Thank you to our residents for your cooperation. The "**TOTES ONLY**" rule began **MARCH 3, 2014** for garbage and recycling and <u>is now in effect</u>. All trash and recycling must fit in their respective tote with the **LID CLOSED**, **or it will not be picked up**.

Basic Sanitation Guidelines for RUBBISH, ELECTRONICS, and DO IT YOURSELF projects still apply:

1. Excess trash may be brought to the Highway Department, 39 South Avenue, Monday–Friday, 7:30 am -3:30 pm with Proof of Residency.

ABSOLUTELY NO CONTRACTORS, CONTRACTOR VEHICLES, OR DEBRIS GENERATED BY A CONTRACTOR WILL BE ALLOWED.

2. Any regular garbage can or old recycling bin placed at the curbside <u>with or without garbage</u> <u>will be taken with the trash</u>. **The only acceptable use for either will be for <u>yard waste</u>**.

Tote Placement

When placing totes at the curbside, please make sure your totes are:

- At least 4 feet from parked cars, trees, mailboxes, utility poles, etc.
- Placed with ample distance between the BLUE LID and GREEN LID totes.
- Placed on a clear/level space (not on top of a snow bank)

Arrangements may be made for delivery at this time, or for pickup with paid receipt, contact the Highway Department,39 South Avenue, Monday-Friday, 7:00 am – 3:30pm.

Exchange Program:

Residents wishing to exchange their totes for an alternate size, may do so after MARCH 20, 2014 by:

- 1. Calling the Highway Department at (716)674-4850, Ext. #18 and leaving your NAME, ADDRESS, and TELEPHONE NUMBER. Please make sure your 95 gallon tote is visible from the street.
- 2. Residents may bring their tote to 39 South Avenue, Monday—Friday, 7:00 am 3:30 pm and exchange it at the Highway Department.
