ISSUES OF THE PUBLIC

- A Sunrise Terrace resident commented on private contractors that plow snow onto sidewalks in his neighborhood and the surrounding area, forcing pedestrians to walk in the street. Senior Code Enforcement Officer John Gullo stated when private snow plow contractors file for their permit they are provided with instructions on what they can and cannot do. Residents should contact his office if they see sidewalks that are not shoveled.

ISSUES OF THE PUBLIC

- A Covington Drive resident questioned an item on the last Town Board agenda that amended the bond resolution for sewer districts 5, 13 and 20. Supervisor Meegan stated the item was a legal request from Environmental Facilities Corporation to amend the language in the bond resolution to include the \$1.7 million in grant money received. The resident questioned if the \$30 million bond is being used for work in areas outside of sewer districts 5, 13 and 20 and noted the consent order only mentions districts 5 and 13. Town Engineer Steve Tanner stated work has been done in other areas, but not with money that has been bonded. Along with districts 5 and 13, the consent order mentions East & West, Angle and Leydecker Roads which make up sewer district 20. The resident further commented on the six sewer lines on her tax bill and stated she would like to know when each line will come off the bill. Councilman Hart stated he is researching this question and it may be how the districts were established many years ago.
- A Covington Drive resident stated his house was built to code in the 1950's and questioned how a law can be adopted afterward that requires something be changed. Town Engineer Steven Tanner responded that laws change all the time and new local laws are adopted every year. Under the current law, the town can force a homeowner to fix illegal connections, but the town believes in being reasonable to the residents. Councilman Hart stated many changes come about as a result of changes at the state level which supersede the town. The Covington Drive resident questioned if the entire town benefits from the work in sewer districts 5 & 13. Mr. Tanner responded many small districts flow directly into the City of Buffalo, but for the most part all districts benefit. The resident further questioned the status of the pumps by West Senior High School. Mr. Tanner responded the project has not been allowed by the DEC and the town is trying to get approval.
