**PUBLIC COMMENTS ON COMMUNICATIONS**

- Residents referred to Item #2 regarding the recreational sprinkler system with the following comments/questions:
  - ✓ Are the sprinklers for recreational use – Councilman Hanley stated the sprinklers are for the children. Councilman Bauer replied the intent was to have something for children after abandoning the Recreation Department this year.
  - ✓ Should not be spending money for recreational sprinklers due to budget concerns – Councilman Hanley replied the summer programs were budgeted for. The town took \$122,000 from the tax payers and then decided to close the pools. Taxpayers are getting nothing for their money this year.
  - ✓ Would the area behind the pool be a better location for the sprinklers – Councilman Bauer explained that area was considered; there are power and water sources by the Lions Bandshell with money in the budget.
  - ✓ Suggested a spending freeze

**PUBLIC COMMENTS ON COMMUNICATIONS** (continued)

- ✓ Concerns regarding social distancing, liability for accidents, and hours of availability – Town Attorney Tina Hawthorne stated the sprinklers would be available from dawn until dusk. The sprinklers have motion sensors and are not continuously on; similar to playgrounds in town that are not staffed. Ms. Hawthorne stated she has no concerns about insurance coverage and the sprinkler heads are not made of metal. The Governor’s interim guidelines that apply to pools also apply to aquatic sprays, i.e. social distancing between groups of no more than 10 people and participants policing themselves; there will be signage on site with rules and expectations. Highway Superintendent Brian Adams explained there will be four zones and Highway will be able to control what zones will be on. Different adjustments can be made such as timers being set, water pressure and sprinkler heads; it is not a permanent fixture and it’s a trial and error situation.
- ✓ Use of the mushroom instead of the sprinklers – Highway Superintendent Brian Adams stated the wading pool area with the mushroom would have to be staffed.
- A resident referred to Item #1 regarding the Veterans Park comfort station and pavilion grant stating the money from the state is not necessarily there for the town to be reimbursed. Councilman Hanley commented all work has to be completed this year. Supervisor Dickson stated the town can request an extension according to direction received from the town’s grant writer and he put this item on the agenda to have a discussion

On the question, Councilman Hanley stated the intent was to provide comfort station/restrooms closer to the bandshell for the audience’s use. Councilman Piekarec stated he is in favor of completing the project in two phases, starting with the comfort station and then the pavilion. Councilman Hanley reiterated the need to apply for an extension if both phases are not completed by next March. Town Attorney Tina Hawthorne advised that the town is more likely to get an extension if phase one was already started. Councilman Cantafio stated he would like to start phase one and reviewed historical DASNY grants given during the recession and did not find any that were not reimbursed. Councilman Bauer is in favor of the projects and completing them in two phases while utilizing town employees for some of the work to cut costs. Supervisor Dickson agrees it is very likely the town would be reimbursed and doing the work in phases is a good decision.

2. Councilman Bauer re Purchase of recreational sprinkler system
- Motion by Councilman Bauer, seconded by Councilman Hanley, to approve the purchase and installation of a recreational sprinkler area in Veterans Park at the cost of \$3,500 from Property Optics Irrigation & Lighting noting, the funding will come from the Highway Department's budget.

On the question, Councilman Piekarec stated money in the budget does not mean it has to be spent; given the uncertain financial times it would not be prudent and sprinklers are something people can do for their own families. Supervisor Dickson stated although the proposal comes from a very good place this is something people can do in their own yards. The sprinklers are temporary and would like to plan for something more permanent in the next year's budget. Supervisor Dickson questioned if multiple bids were received. Councilman Hanley stated this was not bid out as the amount falls well within the town's procurement policy. Councilman Cantafio appreciates the points made, but because so many things have been eliminated due to COVID-19 and the money is available to provide the kids with something he supports this idea. It would be a good will measure for the community.

3. Town Engineer re Bid award for Phase 6 Sanitary Sewer Rehabilitation

### **ISSUES OF THE PUBLIC**

- A resident expressed dissatisfaction with the closing of the pool - Supervisor Dickson stated the town is part of the state and must follow state laws
- A resident complimented the planters around the building – Supervisor Dickson replied several residents took the initiative to improve them
- A resident commented they would like to see the town bid out all projects
- A resident commented/questioned the following:
  - ✓ The business at 537 Potters Road put out a sign without obtaining a permit
  - ✓ Could not find any information about the Traffic Safety Committee online, believes there should be transparency and requested the speed limit be lowered on Covington Drive – Highway Superintendent Brian Adams explained the committee is an internal committee comprised of himself, Chief Denz, and a few other members of the Highway Department. When issues are brought up they are addressed. A digital sign was placed on Covington Drive for 14 days which recorded 1100 cars per week with an average speed of 26 mph. Councilman Piekarec questioned the status of the proposed speed bumps. Councilman Hanley stated there is money for them but the traffic committee denied them.
  - ✓ Suggested a hiring and spending freeze during this time – Supervisor Dickson stated the board is not replacing all employees who are retiring, stretching out replacements of vacated positions and lowering job titles. Contract negotiations with the PBA are underway with Blue Collar to follow. Furloughs and layoffs are not very efficient due to the costs the town incurs and the trauma to employees. Councilman Hanley is in favor of replacing police officers, the town is currently down eight officers, but there are no candidates due to the Police Academy being closed. Chief Denz stated as of Friday the number will be nine, in two weeks it will be ten, and he expects it to be fourteen by the end of the year.
- Is The Sun newspaper one of the town's newspapers and stated residents with the zip code 14224 get a free copy with the Buffalo News on Fridays but not West Seneca properties with zip code 14220 – Councilman Hanley stated the West Seneca Bee is the preferred town newspaper. Councilman Piekarec stated the Town Board cannot require the newspaper to give people a free copy.
- A resident was very glad to hear the sprinklers are going forward
- A resident made the following comments about the neighborhoods north of Route 400:
  - ✓ Thank you for repairing the basketball hoop
  - ✓ Upset the park on Mineral Springs and Indian Church Road has been signed over to the City of Buffalo when the children in the West Seneca neighborhoods should be able to use it
  - ✓ Please contact Erie County to have the orange bag on the island by the entrance to the 400 on Seneca Street cleaned up and to repair the holes in the curb lanes on Seneca Street in that area
- A resident commented/questioned the following:
  - ✓ The Police Department has done a phenomenal job
  - ✓ The Town Board has done a good job; please keep the senior residents in mind when spending tax payer money
  - ✓ Is the town obligated to cover any deficit the school district may encounter - Supervisor Dickson stated the town is not as the two are separate.

- Flooding at Fisher Court that occurred on June 2, 2020:
  - ✓ Received a petition with approximately 150 signatures from residents from Fisher Court asking for the town to help fix the problems.
  - ✓ Joined Highway Superintendent Brian Adams among others to review the flooding from storm water that flooded basements
  - ✓ Spoke with residents, engineers, and Erie County
  - ✓ Issues with the drainage ditch discovered
  - ✓ Sanitary sewer system in much of the town is old and water infiltrates it; much of the work involves fixing pipes that are affected; repairs are paid by properties within the sewer district where the work is being done
  - ✓ Meeting held with Erie County on July 1, 2020 to discuss status of Erie County sewers in Erie County District No. 1, this is where water in Sewer District No. 12 flows into and was told by Erie County the pipes were clear. Further tracking reveals the water then flows into West Seneca Sewer District No. 5 - which is a larger pipe but has had problems with capacity.
  - ✓ Engineers are looking at possible solutions to increase the capacity of the pipe; NYSDEC is not supportive of increasing the capacity; will be taking a team approach in combination with Erie County, the Buffalo Sewer Authority, and representatives in Albany to work with the NYSDEC to resolve this so sewage does not back up in residents homes
- Supervisor Dickson reminded all that Town Hall has been open for a few weeks and the safety measures in place are working extremely well; would like to see the kids return to school in the fall so keeping the infection rate down is the top priority.

**Highway Superintendent Brian Adams**

- Walked the drainage ditch in the backyards of Nancycrest Lane on July 2, 2020 and found it to be fairly open, some areas were overgrown and they will be cleaned up, this does not appear to be the main cause of any flooding; it resulted from 2-3" of rain water within an hour and a half, high winds, and garbage on the curb for pickup the next day was found to be covering the rain intakes on the road
- Placed a call to the NYSDOT regarding U.S. Route 219 to be certain all affected departments are on the same page with the cleanup efforts
- The storm drains and the roads have been evaluated – everything is flowing properly; they are not designed to handle that amount of water
- Reminded residents of the East & West Road project that is underway including the replacement of a culvert just past Angle Road
- The Highway Department is continuing road projects including St. Davids Drive, a few streets behind the Southgate Plaza, Southwood Drive, and Willowdale Drive
- Confirmed for Councilman Piekarec that National Fuel that would do the work on gas lines on Duerstein Street

# AGREEMENT

THIS AGREEMENT made this 13<sup>th</sup> day of July 2020 by and between the Town of West Seneca, New York (the "Town") and the Erie County Society for the Prevention of Cruelty to Animals d/b/a SPCA Serving Erie County, a not-for-profit corporation having an office located at 300 Harlem Road, West Seneca, New York, 14224 (the "SPCA").

## WITNESSETH

WHEREAS, the Town and the SPCA desire to enter into a contract providing that after the statutory holding period as per New York State Agricultural and Markets Law, a seized dog may be offered for adoption according to New York State Agricultural and Markets Law, Article 7 and Article 26.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. During the term of this Agreement, SPCA will only accept dogs that it considers safe adoption candidates after they have been held the legal stray holding period as determined by NYS Agriculture and Markets laws. The Town will be responsible for identifying dogs who are overtly behaviorally unsound, suffering irredeemably, or dangerous with people or other animals. In that event, the Town shall be responsible for the animal's humane euthanasia at the veterinary facility of its choice. The Town understands that its representatives are welcome to contact SPCA's behavior department with any questions pertaining to behavior or temperament.
2. The term of this agreement shall commence on July 13<sup>th</sup>, 2020 and shall end on December 31<sup>st</sup>, 2020 and shall be automatically and continuously renewed for each succeeding calendar year until the Town or the SPCA provides written notice to the other, at least thirty (30) days prior to the commencement of the succeeding year, of its desire to terminate this Agreement.
3. The Town understands that it is their sole responsibility to seek and provide veterinary care for a sick or injured impounded animal. The Town agrees to seek said care from a licensed Veterinarian, and to adhere to the care/treatment recommendations from said Veterinarian. Contact information for the Veterinarian(s) routinely worked with by the Town will be furnished to the SPCA by 9/01/2020. Furthermore, the Town understands and acknowledges that failure to provide medical care to an impounded animal in need may immediately void this agreement and could lead to criminal charges.
4. In the event the Town feels that the physical condition of the dog at the time of initial impoundment may rise to the level of animal cruelty, the Town understands it may contact the SPCA. The SPCA agrees to arrange for the Town to bring the dog to the shelter and to have a member of its medical and/or Law Enforcement team examine the dog. If the SPCA deems the condition of the dog may in fact be evidence of the crime of cruelty to animals, the SPCA will accept said dog, hold the dog stray time and open an investigation. The Town understands that it must take the dog back, hold stray time and to provide medical treatment as described above in the event the SPCA declines to accept the dog for further investigation.
5. In the event that a dog relinquished by the Town to the SPCA is subsequently euthanized due to significant medical or behavioral problems, the euthanasia shall be performed by registered Licensed Animal Health Technicians employed by the SPCA and shall be carried out humanely with an injection of sodium pentobarbital.
6. The Town agrees to send all dogs that are physically and behaviorally healthy to the SPCA.
7. The SPCA will accept dogs as space permits. The Town agrees to call ahead before transporting a dog to the shelter. The SPCA understands that if space does not permit, the Town may seek alternative placement for the dogs with other organizations.
8. The Town agrees to pay the SPCA the following fees for services rendered pursuant to this Agreement per dog:
  - a) An adoption fee of thirty-five dollars (\$35.00).
  - b) A euthanasia fee of thirty (\$30.00).
  - c) A crematory and disposal fee of thirty (\$30.00).

Also, the Town understands it is its sole responsibility to provide animal control services for its municipality.

The fees accrued during each month shall be paid no later than the fifteenth day of the next subsequent month.

9. If it is necessary for the SPCA to accept a stray dog found within the Town, the Town agrees to pick up said dog within 4 SPCA business hours of receiving a phone call from the SPCA. The Town understands that if the dog is not picked up, there will be a \$50 transport fee for an SPCA representative to deliver the dog to the Town's Animal Control Office. Additionally, if the Town fails to retrieve the dog within 4 hours or is unavailable to accept said dog upon SPCA arrival to their holding facility, the Town agrees to reimburse the cost of care for the dog at the rate of \$25.00 per day.
10. The Town agrees to send all Animal Control Officers, Dog Control Officers or any Agent of the Town acting in such a role where they have a responsibility to feed, clean, house, walk, accept, pick up or in any way interact with or provide care for animals as part of their Town duties to an annual 8 hour training scheduled and hosted by the SPCA.
11. The Town understands that the SPCA will make a minimum of one annual visit to the Town's holding facility and agrees to permit SPCA representatives access to all areas of said facility.
12. If for any reason the Town accepts and transports an owned animal for surrender, the Town understands the SPCA will not accept said animal without a completed SPCA Owner Surrender profile, paper proof of permanent ownership relinquishment to the Town, and reliable contact information for the previous owners.
13. The Town agrees to scan all stray dogs for a microchip, and to fully document any and all attempts to contact the registered owner. The Town understands that if a microchip is detected by the SPCA upon transfer, and it was not previously discovered by the Town, or the Town made no attempts to contact the owner, the SPCA will hold the dog for a period of 48 hours while attempt(s) are made to contact and locate the registered owner. The Town agrees to pay the SPCA for the additional holding period at a cost of \$25.00 per day.
14. The Town and the SPCA each agree to cooperate and assist the other in fulfilling the terms of this Agreement.
15. The parties hereto represent and warrant to each other that they each have the full right, power and authority to enter into this Agreement.
16. This Agreement may only be modified or amended through the written consent of both parties hereto.
17. Each party agrees to indemnify the other party, its directors, officers and employees from and against any and all claims, actions, liabilities, damages, costs, expenses and reasonable attorney fees, including, but not limited to, those for personal injury and/or death and/or property damage, that arise against or are incurred by the Indemnified Party as a result of any breach, performance or non-performance by the Indemnifying Party of the terms and services set forth in this Agreement or from any negligent or intentional acts or omissions of the Indemnifying Party, its employees, or agents.


The provisions this section shall survive the termination of this Agreement.
