WHEREAS, on June 26, 2017 the Town Board adopted a resolution authorizing issuance of \$300,000 in serial bonds to finance the purchase and implementation of new governmental accounting software; and

WHEREAS, a petition to submit the resolution to a permissive referendum was not filed with the Town Clerk within the statutorily required thirty (30) days of its adoption; and

WHEREAS, the resolution became effective on July 26, 2017; and

WHEREAS, Chapter 195 of the New York State Laws of 1989 provides that towns may temporarily advance moneys from one fund to any other fund; and

WHEREAS, the town's General Fund has available cash at May 7, 2018; now, therefore, be it

RESOLVED, the Town Board does hereby authorize the General Fund to provide a short term interfund loan in the amount of \$300,000 as of May 7, 2018 to support the Capital Projects Fund to be repaid upon receipt of bond proceeds.

ISSUES OF THE PUBLIC

- A Harwood Road resident questioned if Town Board meetings will be moving to the new building and if they will be using the current sound system. Supervisor Meegan responded the meetings will be held in the new Community Center & Library. The sound equipment is the property of the courts and will be staying in the court room.
- A Harwood Road resident suggested Chief Denz put an article in the newspaper about walking dogs and riding bicycles in the dark while wearing dark clothing.

ISSUES OF THE PUBLIC

- A Harwood Road resident questioned what was happening in the Queens Drive area off Center Road. Highway Sup't. Matthew English responded there was mud coming through the blacktop and his department dug it up. They are now waiting for available funds to fix it.
- A Harwood Road resident questioned if the money received from recycling comes back to the town and suggested the town encourage residents to recycle more. Town Attorney John Fenz responded the town receives a quarterly rebate.
- A Harwood Road resident questioned the cost to dispose of a television. Highway Sup't. Matthew English stated the fee is \$5 for non flat screen TV's.
- A Burch Avenue resident stated a 5K race went past her house and the residents were not notified. Councilman Hanley stated the town was made aware of that and the residents should be notified of races that are scheduled.
- An East & West Road resident thanked Highway Sup't. Matthew English for installing the fence at Firemen's Park to prevent baseballs from leaving the park. Mr. English stated he received calls from neighbors and they are not happy with the fence.
- A Woodward Crescent resident questioned if the house next to Firemen's Park is being demolished. Supervisor Meegan responded the house will be demolished, but funds are not yet available.
- A Woodward Crescent resident questioned why Director of Finance Megan Wnek was designated to prefer disciplinary charges on a department head rather than the Human Resources department. Town Attorney John Fenz responded pursuant to statutory law the person had to be an employee of the town.
- A Woodward Crescent resident referred to the voucher report and the cost of heating at the soccer field. Highway Sup't. Matthew English stated he believed the cost was associated with a broken pipe and will check on it.
- A Union Road resident referred to Item 6 on the agenda concerning a budget amendment and questioned if there was an error because both funds were being increased. Town Clerk Jacqueline Felser responded this is a budget amendment that increased an income line and a corresponding expense line.
- A Union Road resident questioned the year end budget transfers. Supervisor Meegan responded the budget transfers are done within each department to zero out the various line items.

ISSUES OF THE PUBLIC

- A Union Road resident questioned the \$300,000 bond for accounting software. Town Attorney John Fenz stated bonding was approved in 2017, but the bond has not yet been issued. A short term interfund loan was approved and the bond will repay the loan.

PRESENTATION OF COMMUNICATIONS BY BOARD MEMBERS AND DEPARTMENT HEADS

SUPERVISOR MEEGAN

- The Burchfield Center will open May 15th under the direction of Carol Yetter with the Seneca Nation holding an event on May 18th. The classroom is the only area being opened; air quality testing was completed and received a good rating.
- All 17 West Seneca parks are smoke free and signs will be posted.
- National Nurse’s Week was acknowledged and nurses thanked for their hard work.

COUNCILMAN HANLEY

- Update on \$175,000 invoice from Erie County - The invoice appears as a sewer bill, but is actually due to assessment challenges that were won and the county is now requesting their portion. He will meet with Assessor Kandace Wittmeyer to review the assessment challenges and ensure they are correct. Town Attorney John Fenz requested that he be copied so he can also review them.
