TOWN ENGINEER STEVEN TANNER

- Community Center & Library Project
 - ✓ Change orders for community center & library project – Frey Electric \$3211 & MKS Plumbing \$2006
 - ✓ General contractor is finished - some roofing still to be done, site work, punch list items
 - ✓ Will hold back a 10% retainer until satisfied with project and punch list items are completed
- Tim Russert Park comfort station
 - ✓ Minimum cost will be \$80,000
 - ✓ Councilman Hart suggested a community development block grant (CDBG) project
 - ✓ Supervisor Meegan noted Dorrance Avenue park has been in line for a comfort station and also falls within the CDBG area

COUNCILMAN HART

- Attended a meeting with Jerry Hathaway and representatives from Ebenezer Railcar Services regarding their proposed project; Town Attorney John Fenz advised that NYSDEC and Army Corps of Engineers would like to walk the site
