#### **CONTINUED BUSINESS**

A. <u>Playgrounds</u> – Chairperson Sugrue stated Highway Superintendent Adams indicated his department's playground priority list should be available in January and the commission should plan to compare their notes with the Highway Department list.

Councilmember Breidenstein stated Town Board approval for the purchase of playground equipment for Dorrance Park was given to Highway Superintendent Adams at the November 18<sup>th</sup> meeting and will arrive late winter to early spring. Chairperson Sugrue commented that approval for playground equipment for Firemen's Park was previously given. Councilmember Breidenstein confirmed this is correct.

Chairperson Sugrue stated she and Mr. Smolen were at Dorrance Park to obtain community feedback noting many people commented on the set-up of the playground as opposed to the equipment. Other comments included the lack of shade and the popularity of the basketball court. Chairperson Sugrue commented on the number of dogs observed and wondered if the area behind the ball field could be used for a dog park. Mr. Bauer stated he believes that area is owned by a radio station. Recreation Supervisor Masset agreed that the town does not own the radio tower; 701 Dorrance Avenue is townowned and 675 Dorrance Avenue is owned by a broadcasting company. Councilmember Breidenstein stated he believes there is also an easement and will investigate this with the Code Enforcement and Assessor's Offices. Chairperson Sugrue stated requests for parking to be more off the road were also made.
