Please note all fees are effective for any use after January 1, 2019, except for Ice Rink Fee which is effective August 14, 2018. These fees were last revised in 2015.

OTHER FACILITY USE FEES (EFFECTIVE FOR ANY USE AFTER JANUARY 1, 2019):

COMMUNITY EVENT FEE \$350.00 \$450.00 (\$350.00/HIGHWAY, \$100/RECREATION)

NOTES:

- ANY USE TYPE MAY BE ASSESSED A BUILDINGS & GROUNDS, HIGHWAY, WSPD OR OTHER TOWN OF WEST SENECA OVERTIME FEE. THIS IS AN ADDITIONAL FEE.
- SPECIAL EVENTS, TOURNAMENTS AND OTHER LARGE EVENTS FEES ARE DETERMINED BY THE WEST SENECA TOWN BOARD AND HIGHWAY SUPERINTENDENT. THESE VARY BASED ON THE EVENT.
- COST MAY BE HIGHER OR LOWER THAN WHAT IS LISTED ABOVE, BASED ON SIZE, CAPACITY AND DURATION OF THE EVENT.
- ANY OF THE ABOVE USES REQUIRE A NON-EXCLUSIVE FACILITY USE AGREEMENT. INFORMATION ON HOW TO OBTAIN AN AGREEMENT, REQUIREMENTS, DEADLINES, ETC... CAN BE FOUND AT WWW.WESTSENECA.NET.
- THE WSCSD AND TWS YOUTH SPORTS HAVE CONTRACTS WHICH LAYOUT THEIR FEES FOR EACH SEASON. THESE HAVE BEEN TOWN BOARD APPROVED. COPIES OF THESE CONTRACTS CAN BE PROVIDED, IF REQUESTED. THEY CAN ALSO BE FOUND ON THE TOWN OF WEST SENECA WEBSITE.
