ALL THAT TRACT OR PARCEL OF LAND, situated in the Town of West Seneca, County of Erie, State of New York, being part of Lot 387, Township 10, Range 7 of the Buffalo Creek Reservation, more particularly described as follows:

BEGINNING at a point in the northeast corner of Sublot 29 Map Cover 2525;

THENCE southerly along the easterly line of said Subdivision Lot 29 a distance of 134.00 feet to the south line of Lot 387, Township 10, Range 7;

THENCE easterly and along the south line of Lot 387, Township 10, Range 7, a distance of 60 feet to the southwest corner of Sublot 28 Map Cover 2525;

THENCE northerly and along the west line of Sublot 28 Map Cover 2525 a distance of 130 feet to the northwest corner of Sublot 28 Map Cover 2525;
