RESOLUTION FOR TOWN OF WEST SENECA
RELEVY CHARGES TO 2021 TOWN AND COUNTY TAX BILLS

BE IT RESOLVED, in accordance with New York State Town Law, Section 198, the Town of West Seneca Town Board has opted to enforce various unpaid accounts for water, omitted taxes, and other unpaid services as indicated below; and

BE IT FURTHER RESOLVED, in light of the aforementioned, the Erie County Legislature shall levy in such sums as indicated below and against the applicable properties as provided for on the Town of West Seneca's Assessor's master computer assessment roll file:
