ORDER CALLING FOR A PUBLIC
HEARING TO BE HELD ON
MARCH 22, 2021

WHEREAS, the Town Board of the Town of West Seneca (herein called the “Town”), in the County of Erie, New York, on behalf of the Water District No. 1, in the Town (herein referred to as the “District”) has caused CPL engineers, duly licensed by the State of New York (the “Engineer”) to prepare a map, plan and report dated January 2021 for the increase and improvement of facilities of the District, consisting of water main replacements along Seneca Creek Road, Transit Road and Lien Road; including fire hydrants, gate valves and service connections, design and any ancillary or related work required in connection therewith as described in said report and

WHEREAS, pursuant to the direction of the Town, the Engineer has completed and filed with the Town Board such preliminary map, plan and report for said increase and improvement of facilities of the District and has estimated the total cost thereof to be \$1,575,500; and

WHEREAS, the Town Board, as lead agency, has given due consideration to the impact that the project described herein may have on the environment and has determined that each of the projects are Type II actions pursuant to the State Environmental Quality Review Act (SEQRA), constituting Article 8 of the Environmental Conservation Law, and 6 N.Y.C.R.R., Regulations Part 617.5;

NOW, THEREFORE, BE IT

ORDERED, that a meeting of the Town Board be held at Town Hall, 1250 Union Road, West Seneca, New York, on the 22nd day of March, 2021 at 6 o'clock P.M. (Prevailing Time) to consider said increase and improvement of facilities of the District and to hear all persons interested in the subject thereof concerning the same;

FURTHER ORDERED, that the Town Clerk publish at least once in the "*West Seneca Bee*," hereby designated as the official newspaper of the Town for such publication, and post on the Town's website at www.westseneca.net, on the front entrance door and rear doors of Town Hall and on the sign board of the Town maintained pursuant to subdivision 6 of Section 30 of the Town Law, a Notice of such public hearing, substantially in the form attached hereto as Exhibit A, the first publication thereof and said posting to be not less than ten (10) nor more than twenty (20) days before the date of such public hearing.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Town Board of the Town of West Seneca, in the County of Erie, State of New York, will meet at Town Hall, 1250 Union Road, West Seneca, New York, on March 22, 2021, at 6 o'clock P.M. (Prevailing Time), for the purpose of conducting a public hearing in relation to the proposed increase and improvement of facilities of Water District No. 1 (the "District"), consisting of water main replacements along Seneca Creek Road, Transit Road and Lien Road, including fire hydrants, gate valves and service connections, design and any ancillary or related work, as described in the map, plan and report dated January 2021 and prepared by CPL engineers. The current approved estimated maximum cost of the project is \$1,575,500, which is proposed to be financed through issuance of bonds by the Town of West Seneca on behalf of the District, payable by levy and collections of assessments on real property in the District. Therefore, the project cost burden is expected to be borne by District property owners throughout the expected term of the bonds. However, the bonds to be issued shall be general obligation bonds of the Town of West Seneca and in the event the amount of assessments collected within the District is insufficient to pay the cost of the project and/or the debt service related to the project, such costs and/or debt service shall be paid from the general Town taxes.
